1. Child Rights and Protection

1.1 Child Help Desk (CHD)

CHD plays important role in rescue of children and reunite with family. Children are very vulnerable due to their limited exposure, physical changes and lack of counseling hundreds of children left home for various pity reasons.

In year 2019-2020 CHD team has rescued 396. The CHD team also has organized 5383 outreach walks at Ahmedabad Railways station and aware 89083 passengers, porters, staff working in various capacities at railway station and yard, daily travelers, rickshaw drivers, parking staff, etc.

For mass awareness generation 9 events have organized. Where in 4270 people were involved.

GANESH

Today 13th February.....Like every day trains were coming at its time. The vendors were selling their services by screaming like; Water... ice cream...idly... etc., Passengers on platform number 1 were also waiting for the train. Other passengers were coming to the station. The team member of the Child Help Desk, Mr Dhananjibhai was form of his duty at that time; they were going to the parcel office from platform number 1, there he looked at a single child. The child was becoming worried and some cry. Volunteer Hansaben also join with Dhanjibhai and they both rescue Child. Child name was Ganesh.

Now CHD team gives proper meal and some hospitality to this child and tries to get some information about his parents or address. Child Ganesh told last night he sleeps with his mother on the platform but early morning she left me alone and go somewhere. CHD team fully investigate about mother on platform but no one knowing about her so now we shift in Child Care Institute in Paldi after produce before him to CWC of Ahmedabad on this day of 13rd February, 2017.

On regular basis CHD staff and staff of CCI also are counsel with Ganesh but we haven't got any information about him or his parents or family. Ganesh told only one thing ''my mother left me on station''. In the same way, time passed out. Ganesh was rescued by CHD this incidence took over become 8 month ago. Now it has been decided that Ganesh is Legal free on 30/10/2017 for Adoption because he is very small so his future make will brighten. However, once again the Press announcement was made for Ganesh. If someone is his guardian so they would be take him, but that would not happen.

Through Adoption process Ganesh adopt by on family who lives in Jamnagar and they have their own printing business.

Now our hope and like is Ganesh future is secure because Childline, children care institute and CWC are available in our social sector who secure future of those children who need care and protection.



1.2 Children's Group

To create awareness among children new methods were introduced. Through games, songs, interactive sessions and Samvidhan kit, developed by Pravah were used in effective way to generate awareness on importance of rights and protection among children.

Under Samvidhan Live project total 174 children of 3 schools were trained and aware on fundamental rights and duties according to the Indian constitution. 284 tasks were performed by these children in their respective village and areas.

147 members of existing children groups in Ahmedabad were also trained and aware through this Samvidhan Live kit.

Along with children their 189 parents, 34 advocacy group members, 5 teachers and 23 Anganwadi (Pre-primary school centre) workers were also consulted, involved and aware.

As innovative approach under Samvidhan Live, communication material was developed considering learning level, reading level and adoption approach of target groups, like posters, small stickers (those can be used on notebooks to write names, standard, division, subject and school name), A8 size stickers and pocket book. This pocket book contains the profile of child with photo and space given to write important contact numbers and health data. For children picture and short sentences for each message were used. The detail of pocket book was decided in consideration with members of children groups.

Posters cover the subjects like, various nutritious food and vitamins available, types vaccination and its schedule, schemes available at Anganwadi and primary school for children and adolescent girls, child rights and protection mechanism with various helpline numbers. To develop these material Anganwadi workers, nutrition expert, ICDS supervisor and CRC coordinator were contacted and inputs taken and also referred material available at Anganwadi.

Process of convergence: Every month we had meetings with all three advocacy groups and five children's groups. Earlier we though to fix days for meetings with advocacy committees but it was not

successful so meetings were planned as per the availability of members. But for meeting with children days were fixed. While Anganwadi workers and teachers visit/meetings were done regularly, at least once in 15 days. We were regularly informed by CDPO and CRC and invited to attend their monthly meetings. In those meeting we were getting opportunity to meet all Anganwadi workers and teachers of that block. These were considered to be good interactive sessions we had during one year. We got one hour of time to present/discuss the topics. We grabbed this opportunity always and sensitized other Anganwadi workers and teachers to wards protection of rights of children. It also helped us in improving quality of education some schools.

Events & Outreach to build capacity and partnerships

The team members were provided training on Child rights and protection, RtE, CLPRA and other acts and policies related with the children, adolescent on their rights and entitlements. The team has been timely informed with the updates and amendments in acts and policies. Members were participated in trainings workshops organized by other networks and organizations. The detail is as below.....

CfD followed different strategies for different stakeholders to reach them.

- i. With children: To reach children, formed children groups (CGs). The 72 members of CGs treated as resource persons and each CG member conveyed the inputs/training given to them; to approx10 more children of his/her chawl, society or locality. This way we could reach to 683 more children. We used Anganwadi, primary school and our own LitClub members (we run LitClubs since 8 years, so we have to reach children.
- ii. With parents/local leaders: CfD works in these areas since many years. We have rapport with community. Through regular interventions and relations, we have identified interested individuals who were ready to give time to work for children and their issues voluntarily. We kept 50% ratio of local leaders and parents in advocacy committees.
- iii. A district level meeting with all partners of Childline, Child Care Institutions, CSOs working on Child Protection was organized. Where in Child Welfare Committee members, District Child protection Unit officials, railway and police departments presented their views and suggestions to strengthen the mechanism for protection of children.

- 3. 3 awareness rallies were organized, one in each area on UN declared Child Rights week.
- 4. 3 health camps were organized in collaboration with AMC hospital.
- 5. Awareness will be generated on child rights and protection mechanism. That will prevent abusive environment in family and area.
- 6. 72 children were trained as change agents on protection of their rights
- 7. 36 advocacy members were involved to monitor the education and health related facilities in the area.
- 8. 301 children from 11 Anganwadis have identified and provided nutritious food on regular basis other than provided by ICDS. Food like Chana, Dates, boil eggs, moong and organic jaggery were given periodically to children. The noting in register of Anganwadis also done for record.
- 9. 612 adolescent girls were monitored and linked with ICDS services through 11 Anganwadies.
- 10. Developed IEC material for campaign.
- 11. Training to Angenawadi workers and helpers

8 trainings – 2 in Ganeshnagar, 6 in Khodiyarnagar and 2 in Bombay Hotel areas were organized for Anganwadi workers and helped in UNCRC, Child Protection mechanism, reporting structures and helpline numbers, POCSO and briefly introduced JJA.

12. 3 interface dialogue meetings were organized with AMC officials. CDPO, UCD and zonal health officials have attended these meetings. Where in issues like upgradation of Anganwadi structure, requirement of joyful leaning material, requirement of more Anganwadi in Bombay Hotel area,

increase number of health workers, requirement of mobile health van and need of two police chowkies for protection of adolescent girls, children and women were discussed and memorandum were given. Advocacy members were attended these meetings.

- 13. 174 children have taken part in Samvidhan Live project where in 284 task were performed on various principles, values, rights and duties. These children were from three schools respectively
 - a. M. J. Shahpurwala School, Kamijala, Viramgam
 - b. Navrachna Secondary School, Ramol
 - c. Adarsh Secondary School, Ramol
- 14. 5 Teachers were also involved in Samvidhan Live exercise.



2. Education

Education and support to formal education is one of the important programs of CfD. This year CfD has reached 1893 children under this program.

2.1 One to One Sponsorship Program

One to one sponsorship program is flagship intervention of CfD. Facilitation and handholding to 323 children, update each and every information, feed-back to donor is hurricane task.

Under one to one sponsorship in 2019-2020 total 234 were sponsored while 427 children got benefited indirectly as siblings of sponsored children.

7 children (6 boys, 1 girl) have cleared 10th while 5 (1 boy, 4 girls) have cleared 12th board exams successfully. 12 children are studying in various graduation courses.

Total 56,16,000 of Rs. sponsorship received by 234 children in this year. Sponsorship money directly deposits in child's bank account.

2.2 Kadam Education Initiative (KEI)

KEI is an exclusive education support program for orphan, single mother daughters. In year 2019-2020 total 76 KEI daughters were supported for their education, health and food security.

This program has added tremendous confidence in girls. Daily interaction through education classes, sharing meetings, opportunities to visit different places, available reading material and live interaction with mothers of these girls created new positive atmosphere in their family and around individual girls. Fear to go out and speak to unknown person, safety measures during travelling and handle unknown persons are added new skills in them.

Samvidhan Live project:

In collaboration with Sauhard and Pravah, under Commutiny program CfD has started project with school going children of 9th and 11th standards in three schools, respectively one from rural area and one from urban area. Where in children were taught main values of preamble of Indian constitution.

- 1. Seth Shree MJ Shahpurwala Highschool, Village–Kamijala, Block–Viramgam, Dist.–Ahmedabad
- 2. Navrachna Madhyamic School, Jantanagr, Ramol, Ahmedabad City.
- 3. Adarsh Vidhyalay, Ramol, Ahmedabad City.

In these three schools total 93 boys and 49 girls have provided training on Samvidhan Live.

Child Group members of Ganeshnagar, Khodiyarnagar, Bombay Hotel areas were also given training on Smavidhan Live. Where in 32 girls and 12 boys have participated.

SUCCESS STORIES



JUVERIA

Juveria was 11 years old when she joined Kadam. She lost her father a few years. Her father died due to cancer. When she joined Kadam, we noticed that she was constantly inclined towards her mother. She used to hide behind her mother initially. After a couple of counseling session, we realized that she had social anxiety, which made her constantly cling towards her mother. This disturbed her mother's work as well. Juveria was afraid to leave the house or even go to school without her mother. The situation got serious when her attendance in school dropped- it was not possible for her mother to drop her to school everyday. Fortunately she received educational

assistance from a project of CfD. Later on, she joined Kadam. Counseling helped unfold certain unfortunate episodes in Juveriya's life. Initially, her mother accompanied her to KRCG and had to wait for her almost for 3 hours every day. With gentle counseling, gradually she could identify the reason for her anxiety; the first indicator of success has been that she has now started remaining in KRCG without her mother. From a shy, frightened girl she has started making friends and interacting with other girls in Kadam, and participating in all the activities.

Currently, she is 15 years old and studies in 10th grade. She is preparing for her upcoming GBSE board exams. Although, she is working hard, she is not able to cope with a few subjects. She is good with Mathematics but her languages (English and Gujarati) are weak. Due to Corona and lockdown, she was not able to come to the center, where Radha teacher taught her. Post the tablet distribution; with the tablet, she is able to continue her studies from home. Everyday she takes tuitions for 2 hours via video call. Her academic base was poor; hence, we started with polishing that first. Gradually, her concepts are getting clear. With this she is able to learn better. Juveria's mother wants her to study well and make a brighter future for herself and her family. She is doesn't want Juveria to get married, instead she wished that Juveria works well and becomes successful. Juveria wishes to become a teacher. She wants to educate children, instead of mere teaching. As she says, "our teachers make us by-heart the books and notes. I don't want to do that. As I am learning the base and clearing the concepts, I want that in future, when I teach, my students also receive this type of education." Her goal is clear for a long time now. This makes the process of choosing the right subjects in future academics, easier for herself and Kadam as well.



KAJAL

Kajal joined Kadam in 2018, when she was 16 years old. Her father died of high diabetes. She dropped her education right after her father died. With no other option, her mother stared working at the vegetable market. She lifts the vegetable baskets, which falls in the labor category. Kajal's mother works very hard, but it is difficult to meet the ends. She has an elder brother who works as a gardener at Taj hotel currently. Hence, the expenses are taken care of for now.

Kajal started as a drop out student 2 years back. Initially, she attended classes at KRCG on regular basis. Post lockdown, she continued to study via video calls on the tablet that is assigned to her. She is preparing for 10th GBSE board exams. Although, she works hard academically, she finds it difficult to grasp. Regular assistance has helped her a lot, yet there a few areas, which need special attention. Currently, she is studying the course of 9th grade, only after which she will start with 10th grade course. We are strengthening her basics and the working on the technical areas of Math and science. Kajal is not sure about her goal. She is still thinking over it. An important aspect to be considered here is that it becomes difficult to think of her career now because she is 18 years old already. She is at an ideal age to get married, as per the norms of her community. Although, her family doesn't oppose her education and her mother wants Kajal to finish her education, but social pressure has been a hurdle for the girls for the longest time. At such times counseling helps. Kajal is bearing pressure for 2 years now. As per the norms of her community, a girl should get married in-between the age of 15-16. Kadam has been providing counseling for last two years and by attending the workshops, Kajal herself has learned to stand out of the norms.

2.3 LitClubs

In year 2019-2020 total 16 LitClubs were functional in 5 areas, respectively Ganeshnagar, Bombay Hotel, Khodiyarnagar and Abadnagar. Where in 206 children attending the sessions of LitClubs regularly, including 129 girls and 77 boys.

LitClubs provide opportunities to learn coexistence, feeling about another person, human values and tolerance. These are basic principles of life to live peacefully and in human way.

In this year to enhance the learning capacity and life skills below program were organized.

ALIYA SHAIKH

One day in LitClub Aliya Shaikh, member of Belonging LitClub and studying in 7th standard, reading about Malala Yousufzai (renowned activist from Pakistan) and her fight against most violent terrorist group on right to education for her self as well as her friends. Malala's story inspired many girls inlcuding Aliya. One odd day she was going to school and one local male resident stopped her and asked to come in home alone. She shouted on that man and informed the local leaders. Next day a small meeting was called in area and all residents warned that man to vacant the home and go some other place. When asking to Aliya, from where she got this gut,

she replied, "in my LitClub we have been teaching many things which are important to protect, develop and make a child confident through various methods. One day when I was reading about Malala Yousufzai, I learned that, she alone stood againt those warloards and not only save her rights but also for other girls and women, I inspired from her story and decided to speak against all odds loudly".



TANVI

Tanvi, zealous girl, always ready to act to fight for any child in her area namely Khodiyarnagar. She is now managing two LitClubs. She says, "when I was member of LitClub I learned so many things. Making friends, sensitivity towards excluded, tolerance, helping those who need care and protection and many incidences happening around the world. LitClub brought whole world in my small house. It changes my perspective of life and behave towards others". Now, Tanvi is not only facilitating two LitClubs but also actively engage in protection of rights of children, adolescent girls

and most vulnerable families. She is friend of Anganwadi (pre-school centre) and helps teachers in keeping the children engage with different activities which she has learned in LitClub.

3. Community Led Action

People's involvement and leadership can be seen in this year too. CfD team has put concentrated efforts in bringing leadership among the people in the communities where organization is working.

The main achievements in this program are here.

1. 3 new CBOs were formed in Ahmedabad city Different Area Orientation training of SS with this CBO also completed, by 21 visit & 7 Meetings, were conducted. The details of CBOs are as below.

5. During year 2019-2020 with help of community leaders and their active participation total 490 entitlements have made available to people.

6. A damage assessment study was taken up in support with Shamaveshi Shaher Samities of Santoshnagar and Kushabhau Thakre nagar. Total 1952 houses were surveyed - 992 apartments in Santoshnagar and 960 apartments in Khushabhau Thakre EWS quarters, Vatva. Following the analysis of the data that emerged from the survey, the findings were recorded and submitted to the Municipal Commissioner of Ahmedabad SS Samities and demand to repair these apartments by AMC as it holds the possession of these apartments. Later on 16/11/2019 a public hearing on the pathetic conditions of the various EWS and BSUP settlements was organized. Leaders from 28 different EWS settlements were invited for the hearing, and the AMC Councillor, assistant director of the AMC Housing Department, activists and person involved in legal support on urban governance and entitlements issues were invited to be on the panel. However due to various reasons only a very few leaders were able to attend the programme. 30 people including community leaders Sarfaraz bhai from Santoshnagar, Pooran Bhai from Vatva, Mukesh Bhai from Naroda and Hanifbhai from Dudheshwar and a few others from other EWS settlements were present. Advocate Shamshad, social activists Sharif Malek and Prasad Chacko listened to the participants and addressed them, after the study conducted by CfD on the dilapidated conditions of housing and amenities was presented by the CfD staff.



7. Night stay in solidarity with homeless on World Homeless Day

As part of national campaign on **"World Homeless Day"** an awareness program was organized at Night Shelter located at Vatva BSUP site. Local leaders and Municipal Counsellors were attended program and discussed the issues homeless people facing in their day to day life. As that was winter time, so leaders distributed 250 blankets to needy families.



Campaign and Exposure visits:

- I. CfD organized a 15 day campaign (from 9/10/19 to 24/10/19) for making necessary rectifications in their voter identity cards in 5 areas of Ahmedabad city viz. Santoshnagar, Vatva, Khodiyarnagar, Ganeshnagar and Bombay Hotel (Narol).
- II. CFD andIGSSSorganized the Big World Sleep out near the Vatva night shelter under the over bridge for the homeless, on 7/12/2019. Over 200 homeless people were joined by CfD staff and also residents of the nearby Ambika tube and Durganagar hutments, and participated in cultural programmes late night. Leaders like the Mayor, Deputy Mayor, Municipal Commissioner, the corporator of the Behrampura ward, Municipal officers and the former Chairman of the Standing Committee of AMC were invited. AMC Standing Committee Chairman attended this programme and spoke to the participants. The leaders of the homeless and the nearby hutments spoke regarding the difficulties they have been facing with respect to housing and basic amenities. Cultural group Kalarav Sanskrutik Manch performed for audience. 120 blankets too were distributed by CfD to the homeless during this event.
- III. A team of 3 members of organziation has visited two cities Surat and Indore to understand the development projects which were claimed by respective authorities. Samta in Sural and Janvikas in Indore facilitated our visits.

Contribution of the community/ CBO in the achievements:

- 1. The active participation of various Samaveshi Shaher Samities have brought different services in their respective areas.
 - i. Santishnagar SSS brought drinking water line in their colony with help of Municipal Counsellor and MLA.
 - ii. Installed legal electricity supply meters at Santoshnagar.
 - iii. Ganeshanagr SSS, brought Dy. Municipal Commissioner at site, where around 350 people presented their issues in one interactive session. Immediately Dy. MC sent vehicles to clean the drainage line and installed new lines.
 - iv. Organized various camps and availed different entitlements.

ANKITABEN SATISHBHAI SOLANKI

Ankitaben Satishbhai Solanki resident of Municipal health quarters, Behrampura doing her graduation. Ankita is active in all interventions in the Behrampura area of Ahmedabad City. There are 3 valmiki groups in the area. A 3-month training on beauty treatment and sewing work was offered to 24 women and girls in the area. Ankita has participated in the various training programmes organized by CfD and has been actively supported the livelihood training also. She also has attended training on reproductive health. She does substantial work in assisting people in filling up applications for Adhar Card, and also various schemes; and also,

files RTI applications on various issues in her area as well as other areas. She assisted the women in the sewing training by teaching them how to take the measurement for stitching women's wear. She has committed to assist Valmiki girls in their education so that they could surge ahead in life, secure jobs. She spends 2 hours voluntarily teaching women and girls studying in 7th to 10th standards every day.





Mo. Faiz Malek

Mo. Faiz Malek, resident of Santoshnagar Block 03, House No. 082 completed B.Com and ging for private job, is a member of the SamaveshiShaher Committee of his area. CfD has been working on the rights and entitlements of poor and deprived Dalit and Muslim households in the Santoshnagar area since the past 5 years. In his interaction with the CfD staff working in the area Faiz got to understand the importance of people in the area being organized to influence the process of development of the city and their own areas. The people should be able to secure basic amenities and development entitlements that the government is obliged to ensure

its citizens; in a manner that their children would not have to face the difficulties that they are facing. Faiz is committed to work with the people of the Santoshnagar area; he realized that most of the people did not have voter id cards, Adhaar cards etc. because of which they were being deprived of their rights and entitlements. He also understood the difficulties that the people were facing due to poor construction, lack of amenities, accumulated solid waste not removed by the AMC, lack of sewerage systems and so many other issues. He attended training programmes under the Samaveshi Shaher-2 project which equipped him with information and competence to take on the issues of the people and work towards solving them. He took the lead in his area to use the voter helpline app and verified 59 voter id cards for rectifying errors. He also assisted a number of people in the area to secure caste certificates that are prerequisites for various entitlements. He has emerged as a capable, committed leader of the community and people trust him as a selfless volunteer and leader.

4. Civil Society Engagement

- 1. CISHAA Citizen for Shelter Alliance, Ahmedabad has been formed by likeminded organizations including researchers and academicians to address the issues for inclusive development of SMART Cities.
- 2. Meaningful engagement with GCS (Gujarat Cancer Society) hospital. With their help and support CfD has organized all health camps.
- 3. Seva Setu program and local MLA The ward inspector of PDS from central zone office CfD has managed to fill the forms to get cards under PDS. The local MLA (Member of Lagislative Assembly) provided reccomendation letter to consider all this application on priority ward list under PDS.
- 4. Stone paving and tree plantation was done in coordination with AMC and Urban Local Body (ULB).
- 5. CfD was invited by INHAF for a roundtable conference on PMAY. This was good experience for us to understand the scheme and interact with decision-making government officials. Some eminent persons from civil society organizations, builder, finance institutions and urban development authorities were invited and it was good time to interact with them directly
- 6. CfD is founder member of Awas Adhikar Zumbesh network, Ahmedabad. The objective of this network to create demand for proper housing with all basic amenities and ownership which were provided by state under various schemes to displaced families, including BSUP colonies.

5. Other Development at CfD

- 1. The safty kit was distributed to the valmiki caste people of three areas namely- Behrampura, Isanpur and Shahpur. The kit was distributed to 115 people- 60 male and 55 female. The people do not care about their health and ignore their safty too, hence this saftykit (containing cap, gloves, t-shirt, boots, mask, socks and apron) will keep them safe.
- 2. On 2nd December 2019 a sanitary napkin vending machine was installed and inaugurated in Swaminarayan college at Shah-A-Alam toll-naka to facilitate easy availability of sanitary napkins to all women students. In this event, besides the girl students of the college and their Pro. Anarben Bhatt of the Swaminarayan college, Dr. Safiya Mansuri of the Civil Hospital, members of the Kadam Resource Centre for Girls, police women from the 181 women's helpline and staff of CfD were also present. Sessions on reproductive health of adolescent girls and young women and the importance of using sanitary napkins were rendered. A demonstration of how to use the sanitary napkin vending machine was made, and the girls started using the machine which provides napkins at Rs. 5/- per napkin.
- 3. Chal Chal Agency lead by Ms. Kruti Shah (Architect) and Mr. Sebastian (Architect), both are faculties at CEPT University and teaching urban planning. With their team and intern students in collaboration with CfD, an exclusively designed movable set up of class room was installed at Behrampura Health Quarters. Where in 14 children and 17 youth were using this facility for their studies and also to teach other children of colony. The entire design, material and expenses were born by Chal Chal Agency, while Pushpaben area leader of CfD has taken responsibility to maintain and monitor.


